2025 APPROVED FEE-FIXING & RATE IMPOSITION

LOCAL GOVERNANCE ACT, 2016 (ACT 936) -PART FIVE (SECTION 144-SECTION 169)

In accordance with the powers conferred on the Tarkwa Nsuaem Municipal Assembly by Section 144 to Section 169 of the Local Governance Act, 2016 (Act 936), the following rates have been proposed for the 2025 financial year, starting 1st January, 2025 to 31st December, 2025. It shall be the duty of every person liable to pay these rates at the respective Urban / Zonal Council offices, the Revenue office of the Tarkwa Nsuaem Municipal Assembly, Tarkwa or to any person assigned to collect public trusts monies on behalf of the Assembly on or before 31st March, 2025, unless a person or an entity is exempted from the payment of such rate as stated by section 149 of the Local Governance Act, 2016 (Act 936).
